Copiague Resident Parking Permits Available

Copiague LIRR Station Parking

On May 1, 2017 the Town of Babylon-owned surface parking lots north of Marconi Boulevard near the Copiague Train Station will be made available exclusively to Town of Babylon residents with a free valid sticker permit.

All Babylon residents may apply for this permit starting April 1, 2017. Applications will be available at the following locations:

- Babylon Town Hall, Parking Permit Office, 200 East Sunrise Highway, Lindenhurst
- Online at www.townofbabylon.com

Applicants will be asked to provide proof of residency in the Town of Babylon, as detailed in the application. The parking restrictions will apply to the following parking lots (see map):

- Lot 031-5 – Immediately north of the MTA commuter parking lot, at Marconi Boulevard and Colombo Avenue;
- Lot 031-6 – Adjacent to Lot 031-5, at Marconi Boulevard and Vespucci Avenue.

Residential Permit Parking Only

Effective April 1, 2017 the Town of Babylon will be providing applications exclusively for town residents to park in town-owned parking lots near the Copiague Train Station. Residents must obtain a **free** valid sticker permit. The start date for resident-only parking begins May 1, 2017.

The two lots effected by this change are:

Lot 031-5 – At Marconi Boulevard and Colombo Avenue.

Lot 031-6 – At Marconi Boulevard and Vespucci Avenue.
