RESOLUTION NO. 316 APRIL 25, 2018 ADOPTING LOCAL LAW NO. 9 OF 2018 AMENDING CHAPTER 213, ZONING, ARTICLE XLI, OF THE CODE OF THE TOWN OF BABYLON (Smoking)

WHEREAS, the Town Board of the Town of Babylon having duly called and held a Public Hearing at Babylon Town Hall, 200 East Sunrise Highway, Lindenhurst, New York, on the 25th day of April, 2018 upon the question of enactment of Local Law No. 9 of 2018 of the Town of Babylon, Suffolk County, New York, being a Local Law amending the Code of the Town of Babylon, Chapter 213;

NOW, THEREFORE, be it

RESOLVED AND ORDAINED, by the Town Board of the Town of Babylon that Local Law No. 9 of 2018, of the Town of Babylon, Suffolk County, New York, is hereby enacted as follows and effective upon its filing with the New York State Department of State:

LOCAL LAW NO. 9 of 2018

A Local Law amending the Code of the Town of Babylon, Chapter 213.

EXHIBIT "A" Article XLI: Smoking

Amend:

§ 213-489 Definitions.

As used in this chapter the following terms phrase, words, and their derivatives shall have the meanings given:

SMOKING

To inhale or exhale the smoke of burning tobacco or tobacco substitute or <u>electronic cigarettes</u>, <u>vape pens</u>, <u>vapors</u>, <u>e-liquids</u>, <u>other legal marijuana derivatives or other substances</u> and also to carry burning tobacco or tobacco substitute in the form of a cigarette, cigar, or any other smoke-producing product or device, including pipes.

§ 213-490 Smoking and tobacco use prohibited.

<u>A.</u> It shall be a violation of this chapter for any person to smoke or carry lighted cigarettes or other smoking devices, including but not limited to cigars, cigarillos, pipes, <u>electronic cigarettes</u>, <u>vape pens</u>, <u>vapors</u>, <u>e-liquids</u>, <u>other legal marijuana derivatives or other substances</u> and the like, in Town of Babylon parks, recreation areas, playgrounds, pools, and beaches. Such conduct is prohibited except where conspicuously designated "Smoking Permitted" or otherwise.
