The items listed below must be submitted with the completed application

1. Fee - \$250.00  
Check or money order payable to the Town of Babylon
2. Survey or Site Plan  
Showing all buildings, structures, fences and storage areas
3. Copies of Federal, State and County permits, such as:
  - a. NYS Department of Motor Vehicles Certificates:
    - Dismantler
    - Repair Shop
    - Dealer Used
    - Scrap Processor
  - b. NYS Department of Environmental Conservation approval for storm water discharges
  - c. Suffolk County Department of Health Services approval for collection and storage of waste oil, antifreeze, waste gasoline and any other hazardous liquids
4. If applicable, receipts to verify disposal of waste oil, antifreeze, waste gasoline and any other hazardous liquids
5. If applicable, Property Owner's Endorsement form must be completed

All licenses shall expire annually (on December 31<sup>st</sup>) and must be renewed. As a condition of the license, the premises shall be suitably maintained.

Upon receipt of the application, a site inspection will be performed and it may be determined that an updated survey or site plan is required.
