- Completed application. All applicants must have notarized signatures.
- Proof that the applicant has been electronically fingerprinted through a New York State Division of Criminal Justice Services (DCJS) approved Statewide Vendor-Managed Civil Fingerprint Capture System.
- Valid NYS Driver’s License or Valid NYS Non-Driver’s License
- Two (2) full-faced color photos of each applicant taken within thirty (30) days of application and measuring 1 ½ x 1 ½ inches
- Business Certificate, DBA (Doing Business As) Certificate or NYS LLC
- New York State Sales Tax ID Certificate of Authority
- Suffolk County Department of Health Food Managers Certificate
- Veteran’s Exempt Card – if applicable

If peddling from a Vehicle.

- Valid Vehicle Registration (both car and trailer registrations if applicable)
- Certificate of Liability Insurance for vehicle (Insurance Binder **NOT** Accepted) If peddling from a Vehicle.
 - **Must be on an Accord-25 form. NO ACCEPTIONS**
 - \$100,000-Bodily injury per person
 - \$300,000-Bodily injury per accident
 - \$50,000-Property Damage
- Fees must be paid in **CASH OR MONEY ORDER** only
 - \$250.00-Peddling from a Motor Vehicle
 - \$150- Peddling from a Pushcart or non- motorized vehicle
 - \$50- For each and every person peddling or assisting a peddler from a vehicle. (Licensee must be present)
 - \$50-For each and every person peddling or assisting a peddler from a vehicle. (Licensee must be present)
