REQUIREMENTS FOR SUBMITTING A PLUMBING APPLICATION

- Fully completed Plumbing permit application must be printed on legal size paper (sized to fit 8½ x 14). Applications will **NOT** be accepted on 8½ x 11 or on two separate pages.
- Plumber's Liability (ACORD) and Workers Compensation (Forms C-105.2, U-26.3 or SI-12) insurances must be provided with every application.
 - Liability Insurance must include: the **plumbers name** and **business name**, Town of Babylon as additional insured and Town of Babylon as certificate holder.
- Copy of Building Permit (if necessary)
 - Building permit (if necessary) must be issued before a plumbing permit application can be filed.
- Accessory Apartment application must be filed before a plumbing permit can be issued.
- Riser diagram (if necessary)
- If filing for HVAC, please provide ductwork sketch, Manuals J, D &S, and EPA License #.
- If filing for any gas work, please include a gas piping diagram and deed if recently purchased property.
- Make checks payable to Town of Babylon.
- Both homeowner's and plumber's signatures must be original and notarized. Photocopies of signatures/notary stamp will not be accepted.
- Please check if your application has all of the required documents. Unfortunately, the entire application must be returned if incomplete.

- Must bring copy of the issued building permit with plumbing application.
 - NO PLUMBING PERMIT CAN BE ISSUED WITHOUT THE PROPER BUILDING PERMIT BEING ISSUED FIRST
